# **Key Responsibilities**

- Develop and deliver lesson plans aligned with curriculum guidelines.
- Provide individual and group counselling to students with diverse learning, emotional, and behavioral needs.
- Work closely with teachers, parents, and support staff to develop and implement personalized support strategies.
- Facilitate social and emotional development, coping skills, and resilience among students.
- Conduct assessments and maintain accurate records of student progress and interventions.
- Develop and deliver workshops or guidance sessions addressing personal, social, and academic growth.
- Advocate for students' needs and ensure access to appropriate resources and accommodation.
- Support transition planning for students moving between grade levels or preparing for post-secondary pathways.

- Advocating for students and connecting them to external resources.

- Assist teachers in preparing and delivering lessons, activities, and learning materials.
- Provide one-on-one or small group support to students, especially those with special needs, to reinforce learning and build confidence.
- Support classroom management by helping maintain a positive, safe, and inclusive environment.
- Assist students with personal, social, and behavioral development as guided by teachers or counsellors.
- Supervise students during non-classroom activities (lunch, recess, field trips, etc.).
- Assist with record-keeping, lesson preparation, and other administrative tasks as needed.
- Collaborate with teachers, guidance counsellors, and other staff to support student learning and wellbeing.
